_____ I understand that swimming lessons are physically strenuous activities and that I or my child will be exerting ourselves during this activity, and that if I or my child am injured as a result of a heart attack, panic attack, hyperventilation, or other unforeseen medical issues, that I expressly assume the risk of said injuries and that I will not hold the above listed individuals or government entity responsible for same.

_____ I hereby agree to fully assume all risks foreseen or unforeseen while on the premises or on, in, entering, or leaving the water. I also understand that spear fishing, firearms without the proper permit, and alcohol are forbidden. I agree to abide by the warning and restrictions printed thereon.



_____ I further state that I am of lawful age and legally competent and not under the influent of alcohol or drugs to sign this liability and release, or that I have acquired the written consent of my parent or guardian, which should be evidenced by a parent or guardian's signature below, or attached to this document on a separate piece of paper and signed by a parent or guardian. I understand that the terms herein are contractual and not a mere recital and that I have signed this document of my own free will.

In case of an accident or injury during this activity, I hereby covenant, promise and agree for myself, my personal representatives, heirs, and next of kin that neither the Tourism, Arts and Heritage Cabinet, Kentucky Department of Parks, nor Greenbo Lake State Resort Park, any of its agents, officers or employees shall be held responsible or liable for any negligence, implied or otherwise, for personal injury or damages suffered or sustained by me or my child in connection with, arising out of, or resulting from any and all activities associated with the abovementioned event or activity.
